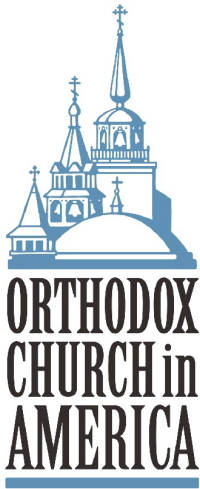

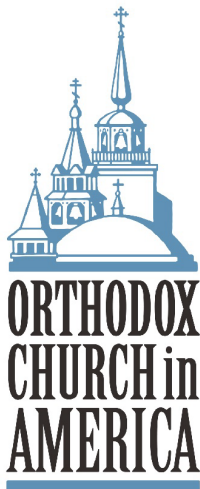

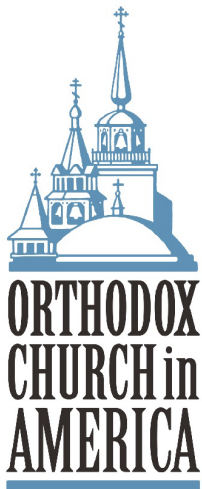
Dissolution of deanery, effective October 23, 2025.

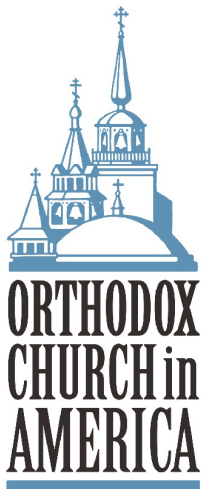
